NOTIFICATION

No. 10606 /Bhubaneswar, dated the 20-5-16
CCA-04/2015

In exercise of the powers conferred by sub-section(2) of section 30 of the Consumer Protection Act, 1986•(68 of 1986), the State Government do hereby make the following rules further to amend the Odisha Consumer Protection Rules, 1988, namely:-

1. (1) These rules may be called the Odisha Consumer Protection (Amendment) Rules, 2016.
(2) They shall come into force on the date of their publication in the Odisha Gazette.
2. In the Odisha Consumer Protection Rules, 1988 (hereinafter referred to as the said rules), in rule 3-, (i) in sub-rule (1), in clause (c), for the words “rupees fifteen thousand per month”, the words “rupees twenty five thousand per month” shall be substituted; and (ii) in sub-rule (2), in clause (a), for the words “rupees twelve thousand per month” wherever they occur, the words “rupees twenty thousand per month” shall be substituted.
3. In the said rules, in rule-6, in sub-rule (1), in clause (b), for the words “rupees twenty thousand”, wherever they occur, the words “rupees thirty thousand” shall be substituted.
