Sub: Advance release of food grain (Rice & Wheat) for the distribution month of March, 2017.

Sir,

I am directed to say that the proposal for liquidation of stocks available in storage godowns and to facilitate receipt of CMR Stock from the Custom Millers for the KMS 2015-16 was active consideration of Government.

After careful consideration, Government have been pleased to decide that the lifting of food grain (Rice & Wheat) for the distribution month of March-2017 in respect of Bargarh, Boudh, Sambalpur, Subarnpur district may be made during the month of January-2017 with the following conditions.

- i. Advance quota of food grain (Rice & Wheat) for the distribution month of March-2017 shall be lifted at par with the quantities released for the distribution month of February-2017.
- ii. Soon after lifting of advance food grain (Rice & Wheat), exact figure shall be reported to this Department for adjustment in the subsequent allotment.
- iii. The quantity of advance food grain so lifted shall be deducted from the allotment of March-2017.
- iv. Wide publicity may be done in the District level and squads from the district as well as state may be made alert to monitor the distribution in the retail points besides movement of food grain to the retail points.
- v. An undertaking shall be furnished by the CSOs of concerned District to which utilization of one month advance food grains (Rice & Wheat) has been allowed for March-2017 that the Districts will ensure delivery of undelivered CMR by 28th February-2017 positively.
- vi. The CSOs-cum-D. Ms. may be suitably instructed to take steps for lifting of advance food grain (Rice & Wheat) immediately.
- vii. Copies of sub-allocation of the advance quota of food grain for the allotment of March-2017 may be made available to the concerned M.P/ M.L.As./ Chairpersons of Blocks/ ULBs for their kind information under intimation to this Department.

You are requested to ensure distribution of food grains to the genuine ration card holders.




