The C.S.O. should progress of lifting of SKO by 10th 20th and 25th of the month and report to Government about bottleneck in transport etc. may be brought to the notice of Government.

The District level S.K. Oil distribution plan should be prepared taking into consideration of the fake/bogus/ghost cards detected.

Due care should be taken that PDS Kerosene is not diverted otherwise or misused for adulteration in MS / HSD retail out lets or commercial vehicles. Stringent action be taken against dealers found indulged in such unfair trade practices. Wide publicity be made on distribution, scale and quantum of supply.
