ORDER

The 1st August 2016

No. 15165—09-17-10-06/2016—In exercise of the powers conferred by Section 3 of the Essential Commodities Act, 1955 (10 of 1955), read with the Order of the Government of India in the Ministry of Consumer Affairs, Food and Public Distribution (Department of Consumer Affairs) No.GSR-104(E), dated the 15th February 2002 published in the Gazette of India, Extraordinary, Part-II, Section 3, sub-section (i), dated the 15th February 2002 as amended from time to time and with the concurrence of the Government of India, the State Government do hereby make the following order, namely :—

1. Short title extent and commencement (1) This order may be called the Odisha Specified Foodstuffs (Stock Holding Limit and Licensing) Amendment Order, 2016.

(2) It shall extend to the whole of the State of Odisha.

(3) It shall come into force on the date of its publication in the Official Gazette of the State.

2. In the Odisha Specified Foodstuffs (Stock Holding Limit and Licensing) Order, 2016 (hereinafter referred to as the said Order) in Clause (3) in Table 1,—

(i) the words and numbers average sale of one month of last three years ending March 2015. Appearing against serial No.1 in Column (3) thereof shall be substituted by the following words, namely:—

Average sale of one month of last three financial years.

(ii) the figures and letters "1000 Qtls." appearing against Serial No.2 in Column (5) thereof shall be substituted by the following figures and letters, namely:—

"500 Qtls." and

(iii) the figures and letters "500 Qtls." appearing against Serial No.3 in Column (5) thereof shall be substituted by the following figures and letters, namely:—

"1000 Qtls."

3. In the said Order, in Clause (4) after sub-clause(5), the following clause shall be inserted, namely :—

"(6) The license fees or renewal fees or fees for issue of duplicate license shall be paid either by deposit of cash in the Government Treasury in the appropriate Head or by Demand Draft drawn on any Nationalized Bank in favour of the Licensing Authority."

4. In the said order, in Clause (5) after sub-clause (5), the following sub-clause shall be inserted, namely :—

"(6) The registration fees or fees for duplicate registration certificate shall be paid either by deposit of cash in the Government Treasury in the appropriate Head or by Demand Draft drawn on any Nationalized Bank in favour of the Licensing Authority."

5. In the said order, in Form D, the word "pulses" appearing in second Paragraph shall be omitted.
