Sub: Additional allocation @ 25 Kg per family per month to 17,118 APL families of Kandhamal district of Orissa, at an issue price of Rs. 2/- per Kg, to meet the severe food insecurity in the district of Kandhamal for the period from July, 2010 to June, 2011.

Sir,

I am directed to communicate allocation of 427.95 MT of rice per month from July, 2010 to June, 2011 to 17,118 APL families of Kandhamal district to meet the severe food insecurity in the district of Kandhamal.

2. The identified food insecured 17,118 number of APL families of Kandhamal district will be provided with 25 Kgs of rice each @ Rs 2/- per Kg per month.
3. The additional allocation received from Government of India is only for one year. This is a separate scheme called as "scheme for supply of rice @ Rs. 2/- per Kg for APL families affected by riot in Kandhamal district".
4. Instruction should be issued to all the retailers for maintaining separate registers at the FPS level.
5. A list of 17,118 APL families should be prepared and a separate account for this subsidized rice should be maintained at your level. Besides a separate "Issue Book" should be issued for these families. The list containing the details of 17,118 APL families should be furnished to Food Supplies and Consumer Welfare Department.
6. The CSO - cum-District Manager may be suitably instructed to take immediate steps to make financial arrangements with FCI @ Rs 300/- per quintal.
7. Other general instructions regarding scale of entitlement, sub-allocations and enforcement measures etc. communicated vide letter No.13657(30) / Food, Supplies and Consumer Welfare Department dated 20.6.2005 shall remain unchanged except consumer price.
8. Copy of sub allocation may be supplied to concerned Hon'ble M.Ps / M.L.As and Chairperson of P.S. for their information.
