**Sub: Allotment of APL rice for the month of September, 2015 to meet the requirement of prisoners of Jails.**

Sir / Madam,

I am directed to communicate an allotment of APL rice under TPDS against Govt. of India allocation for distribution. The Government of India have allotted 1729 MT of APL rice for each month of April, 2015 onwards till the implementation of NFSA, Out of which an allotment of 282.024 MT of APL rice may be utilized for requirement of Jails at APL rate of Rs.9.30 per kg. for the month of September, 2015 as per Annexure enclosed.

It is mandatory for these Jails to furnish detail requisition on requirement of rice vis-à-vis number of prisoners in every month to the concerned CSO of the district before release of rice. The cost of food grains shall be deposited with the CSO-cum-D.Ms of their districts latest by 20<sup>th</sup> August, 2015 and ensure lifting of the allotted quantity by 31<sup>st</sup> August, 2015 positively as Odisha is a DCP State.

Copies of sub-allocation of APL rice may be sent to concerned MPs/ MLAs/ Chairperson of P.S. / E.O. of Municipalities under intimation to this Department.
