Allotment of rice under Antyodaya Anna Yojana for each month of October, 2011 to December, 2011.

Sir/Madam,

I am to communicate the district wise allotment of 43793.050 M.T. rice under Antyodaya Anna Yojana for each month of October, 2011 to December, 2011 for 12,51,230 Antyodaya families of the State as mentioned in the statement enclosed.

2.(i) Out of allotment of 1897.210 M.T rice under AAY for Kalahandi district 2.520 M.T. will be diverted to Kandhamal District for distribution to the AAY beneficiaries of Lubengarh area of Urladani G.P. of M. Rampur Block of Kalahandi. The aforesaid quantities of rice under AAY will be lifted by the Civil Supplies Officer-cum-D.M. OSCSC Ltd. Kandhamal.

(ii) Out of allotment of 707.560 M.T rice under AAY for Gajapati District 3.640 M.T will be diverted to Rayagada District for distribution to the AAY beneficiaries of Garadama G.P. of Mohana Block of Gajapati District. The above quantities of rice under AAY will be lifted by the Civil Supplies Officer-cum-D.M. OSCSC Ltd. Rayagada.

(iii) Out of 1897.210 M.T of rice allotted to Kalahandi district, 28.14 M.T shall be lifted by C.S.O Rayagada for distribution to the AAY families of Gopinathpur, Kerpai, Odri and Maligaon G.P under Th. Rampur Block of Kalahandi district.

3. The allotted stock may be lifted from the near by F.C.I @ Rs.300/- per quintal and ensure distribution of the same to the Antyodaya families for each month of October, 2011 to December, 2011 @ 35 Kg. per card @ Rs. 2/- per Kg.

4. The C.S.O-cum-D.Ms, O.S.C.S.C. Ltd. may suitably be instructed to take immediate steps for timely lifting of the allotted stock of rice from Food Storage Depot, F.C.I. as per the quantity mentioned in the enclosed statement against their Districts.

5. Copies of sub-allocation of rice for Block/ NACs/ Municipalities may be sent to the M.Ps/ M.L.As/ Youth Associations/ Mahila Samities under intimation to this Department. The Sub-Collectors/ B.D.Os may be instructed to communicate the dealer wise allotment of AAY rice to the Gram Panchayat and retailers concerned for information of General Public.

6. Moreover, you are requested to reduce the quota according to the number of Ration Cards cancelled during campaign from November, 2010 to December, 2010, at the time of making sub-allocation to the blocks and ULBs of the districts.
