I am directed to communicate the district wise break up of 8203.2 MT of levy sugar under Public Distribution System for distribution among the BPL and AAY families of the State for the month of November, 2011 as per the statement (enclosed). The allocation also includes a quantity of 30.3 MT for CRPF, 2.1 MT for NDRF and 32.4 MT for Para-Military personnel.

The allotted stock of levy sugar may be supplied to the BPL and AAY families @ 2 kg. per card @ Rs. 13.50 per Kg. Block/ NAC/ Municipality wise distribution may be made immediately under intimation to M.Ps/ M.L.A.s/ Chairman of Panchayat Samities & Municipalities as well as to this Department. Please ensure complete lifting of stock expeditiously to avoid lapse of State quota. The B.D.Os/ Sub-Collectors may be instructed to communicate the dealer-wise allotment to the G.Ps and concerned retailers for information of General Public. Intensive measures be undertaken to make available of levy sugar at the prescribed scale to genuine consumers and stringent action to be taken against the offending retailers indulging in black marketing and charging higher premium.

You are, requested to distribute sugar based on allotment. A stock of 30.3 MT of sugar may be distributed to C.R.P.F, personnels, 2.1 MT to NDRF personnels, 32.4 MT to Para-Military personnels as per their demand.
