- Out of allotment of 1894.760 M.T rice under AAY for Kalahandi district 2.940 M.T. will be diverted to Kandhamal District for distribution to the AAY beneficiaries of Lubengarh area of Urladani G.P. of M. Rampur Block of Kalahandi. The aforesaid quantities of rice under AAY will be lifted by the Civil Supplies Officer-cum-D.M. OSCSC Ltd. Kandhamal.

The Sub-Collectors/ B.D.Os may be instructed to communicate the dealer wise allotment of AAY rice to the Gram Panchayat and retailers concerned for information of General Public.
