Sub:- Additional allocation @ 25 Kg per family per month to 6842 APL families of Kandhamal district of Orissa at an issue price of Rs.2/- per Kg. to meet the severe food insecurity in the district of Kandhamal in the period from July,2010 to June,2011.

Sir,

I am directed to communicated allocation of 171.05 MT of rice per month from July,2010 to June,2011 for 6842 APL families of Kandhamal district to meet the severe food insecurity in the district of Kandhamal.

2. 6842 number of vulnerable families be identified out of APL families of the district who are suffering from food insecurity due to erosion of their asset bases for the ethnic disturbances.
3. The additional allocation received from Government of India is only for one year. This is a separate scheme called as " Scheme for supply of rice @ Rs.2/- per Kg" for APL families affected by riot in Kandhamal district.
4. Instruction should be issued to all the retailers for maintaining separate registers at the FPS Level.
5. A list of 6842 families should be prepared & a separate account for this subsidized rice should be maintained at your level. Besides, a separate " Issue Book" should be furnished to Food Supplies and Consumer Welfare Department.
6. The CSO-cum-D.M. may be suitably instructed to take immediate steps to make financial arrangements with FCI @ Rs.300/- per quintal.
7. Other general instructions regarding Sub-allocations and enforcement measures etc communicated vide letter No.13657(30)/Food Supplies and Consumer Welfare Department dt.20.6.2005 shall remain unchanged except consumer price.


8. Copy of sub-allocation may be supplied to concerned Hon'ble M.Ps/M.L.As and Chairperson of P.S. for their information.

9. The guideline issued vide this Department letter No.15408 dt.30.8.2010 may be scrupulously followed at the time of distribution of rice.

This allocation is over and above the allocation made for 17118 beneficiaries vide this Department letter No.14879 dt.24.8.2010.

The extension of validity period for lifting of rice for the month of July,2010 to Sept.2010 is being communicated separately.
