Sir,


I am directed to refer to the subject cited above and to say that proposal has already been submitted to Finance Department for making supplementary budget provision for allotment to special adhoc/ additional BPL rice for the month of November, 2011 onwards which is yet to be concurred in by the Finance Department.

To obviate this difficulty it has been decided to allocate special adhoc/ additional BPL rice @ 5 Kg for each BPL family out of the own CMR of MD., OSCSC Ltd.

You are requested to utilize rice from own CMR as per Annexure enclosed for the month of November, 2011 which may be replenished after lifting of such rice from FCI on making of supplementary budget provision by the Finance Department to meet the requirement of the BPL beneficiaries.

Moreover, you are requested to instruct the Collectors to reduce the quota according to the number of Ration Cards cancelled during the campaign from November, 2010 to December, 2010, at the time of making sub-allocation to the blocks and ULBs of the districts.
