The validity period for lifting of the allocation will be 50 days for each allocation month separately, starting from the 1<sup>st</sup> day of the month proceeding the allocation month and ending on the 20<sup>th</sup> day of the allocation month. It will be mandatory to deposit the cost of food grains to FCI latest by 15<sup>th</sup> of each allocation month.

In case any quantity of rice is not required for jails, it should be utilized for PDS distribution.,
