Sir,


I am directed to communicate an allotment of 10.00 MT of APL rice under TPDS for each month of November, 2011 to March, 2012 which may be utilized for requirement of jails at APL rate of Rs.9.30 per kg. as per norms fixed by Home Department.

The validity period for lifting of the allocation will be 50 days for each allocation month separately, starting from the 1st day of the month proceeding the allocation month and ending on the 20th day of the allocation month. It will be mandatory to deposit the cost of food grains to FCI latest by 15th of each allocation month.

In case any quantity of rice is not required for jails, it should be utilized for PDS distribution.,

Copies of the sub-allocation of APL rice may be sent to concerned MPs/MLAs/Chairpersons of P.S. under intimation to this Department.
