Additional allocation @ 25 Kg per family per month to 23960 APL families of Kandhamal district of Odisha, at an issue price of Rs. 2/- per Kg. to meet the severe food in-security in the district of Kandhamal for the period from November, 2011 up to March, 2012.

Sir,

I am directed to communicate allocation of 599 MT of rice for each month from November, 2011 to March, 2012 to 23960 APL families of Kandhamal district to meet the severe food in-security in the district of Kandhamal.

2. The identified food in-secured 23960 number of APL families of Kandhamal district will be provided with 25 Kg of rice each @ Rs. 2/- per Kg per month.
3. The additional allocation received from Government of India is only for one year. This is a separate scheme called as "scheme for supply of rice @ Rs. 2/- per Kg for APL families affected by riot in Kandhamal district".
4. Instruction should be issued to all the retailers for maintaining separate registers at the FPS level.
5. A list of 23960 APL families should be prepared & a separate account for this subsidized rice should be maintained at your level. Besides, a separate "Issue Book" should be issued for these families. The list containing the details of 23960 APL families should be furnished to F.S. & C.W. Department.

6. The CSO-cum-District Manager may be suitably instructed to take immediate steps to make financial arrangements with FCI @ Rs. 300/- per quintal.
7. Other general instructions regarding scale of entitlement, sub-allocations and enforcement measures etc. communicated vide letter No-13657(30) / F.S. & C.W. Department dated 26.6.2005 shall remain unchanged except consumer price.
8. Copy of sub-allocation may be supplied to concerned Hon'ble M.Ps / M.L.As & Chairperson of P.S for their information.




