Sub: Allotment of BPL rice for issue under TPDS for each month from January, 2012 to March, 2012.

Sir,

I am directed to communicate district-wise allocation of 97131 MT rice per month under TPDS for each month from January, 2012 to March, 2012. The break up of 97131 MT of rice is mentioned in Annexure-I & Annexure-II.

2. The district-wise monthly allotment of 83596.175 MT of BPL rice for each month from January, 2012 to March, 2012 is hereby communicated for distribution under TPDS to the BPL consumers as per Annexure-I.

Monthly allotment of 13534.825 MT BPL rice for each month from January, 2012 to March, 2012 is hereby made for distribution under TPDS to the APL consumers in both Rural and Urban areas of KBK districts as per Annexure-II. Out of 2572.600 MT of BPL rice allotted to Kalahandi district 6.75 MT shall be lifted by C.S.O., Rayagada for distribution to the APL families of Gopinathpur, Kerpai, Odri and Maligaon G.P. under Th. Rampur Block of Kalahandi district.

- 3. Out of 2042.975 MT of BPL rice allotted to Kalahandi district, 6 MT shall be lifted by the C.S.O.-cum-D.M., O.S.C.S.C. Ltd., Kandhamal for distribution to the BPL families of Lubengarh village of Urladani G.Ps of M. Rampur Block as they are inaccessible from Kalahandi district.
- 4. Out of allotment of 2042.975 MT BPL rice in favour of Kalahandi district 57.9 MT of rice will be diverted to Rayagada district for distribution to BPL families of Gopinathpur, Kerpai, Odri and Maligaon G.P. under Th. Rampur block of Kalahandi district. The said stock of rice under BPL will be lifted by the C.S.O.-cum-D.M., Rayagada.
- 5. Out of the allotment of 1428.775 MT of BPL rice in favour of Gajapati district, 11.425 MT will be lifted by C.S.O.-cum-D.M., O.S.C.S.C. Ltd., Rayagada for distribution to the BPL beneficiaries of 12 villages of Gordama G.P. under Mohana block of Gajapati district.
- 6. The C.S.O:-cum-District Managers may be suitably instructed to take immediate steps to make financial arrangements with F.C.I. @ Rs.565/- per quintal so as to ensure arrival of the rice at the fair price shops within the first week of the month for which allocation is made.
- 7. Other general instructions regarding scale of entitlement, sub-allocations and enforcement measures etc. communicated vide letter No.13657(30) / Food, Supplies and Consumer Welfare Department dated 20.6.2005 shall remain unchanged except consumer price.
- 8. Each BPL card holder and APL card holders of KBK are entitled to lift 25 kg. of rice @ Rs.2/- per Kg.
- 9. Copies of sub allocation may be supplied to concerned Hon'ble M.Ps / M.L.As and Chairperson of P.S. for their information.
- 10. Moreover, you are requested to reduce the quota according to the number of Ration Cards cancelled during campaign from November, 2010 to December, 2010, at the time of making suballocation to the blocks and ULBs of the districts
