Sub: Allotment of Rice under Annapurna Scheme for the Month of January, 2014.

Sir,

I am directed to communicate the district wise break up of 637.010 MT of rice for the Month of January, 2014 as indicated in the statement for distribution to the beneficiaries under Annapurna Scheme. The rice allocated under the scheme shall be distributed to the beneficiaries @10 kg per card free of cost. The unutilized rice under Annapurna Scheme kept with them may be surrendered to Govt. for re-allotment of the same to the Districts. Since no rice under the said scheme for the balance period of 2013-14 i.e. from October, 2013 to March, 2014 has been released by Government of India, the entire quantity may be lifted from own CMR till receipt of allocation from Government of India.

Out of allotment of 23.17 MT of rice under Annapurna Scheme for Kalahandi district 0.25 MT of rice is diverted to Rayagada District for distribution to the Annapurna beneficiaries of Kerpai, Gopinathpur, Odri and Malligaon G.P.s of Th. Rampur Block.

Besides 0.05 MT of rice is diverted to Nawarangpur district for distribution to the Annapurna beneficiaries of Talnagi GP under Th. Rampur Block.

Municipality /NAC /Block /G.P. wise distribution of the allotted stock of rice may be made under intimation to the concerned M.Ps /M.L.As /Chairman Municipality /PS.

The rice stock should be distributed to the beneficiaries at the place and time as communicated vide this Deptt. letter No. 14261 dt.29.5.2002.
