Sub: Implementation of Welfare Institutions & Hostels Scheme.

Madam/Sir,

I am directed to invite a reference to the subject matter cited above and to say that after implementation of NFSA, the following six number of schemes were being managed by the State Government.

- 1.ST/SC (Govt.) Hostels.
- 2.ST/SC (NGO) Hostels.
- 3. Welfare Institutions
- 4. Kasturba Gandhi Balika Vidyalayas.
- 5. Adrut Children Homes
- 6. Satyabhama Devi College for Hearing Impaired.

A new Scheme namely Welfare Institutions & Hostels is being implemented in the State from the month of October, 2107 and onwards. The beneficiaries registered and uploaded by the concerned Administrative Departments in the Portal specifically designed for the purpose up to 30.09.2017 has been taken into consideration while making the allotment of rice under this Scheme. The issue price shall be Rs.1/- per Kg. for ST/SC (Govt.) Hostels and Kasturba Gandhi Balika Vidyalayas (KGBV) under S & ME dept. whereas Rs.5.65 per Kg. for remaining Institutions included in the new scheme. The scale of issue shall be 15 Kg. per boarder per month in case of adult and 8.5 Kg per boarder per month in case of CCIs.

The concerned administrative Department (W&CD) is requested to update the status of boarders of Child Care Institutions(CCIs) in its OTPDS login immediately to facilitate appropriate release/adjustment in the subsequent bi-annual allotment.

The district wise allotment of rice under WI & Hostels Scheme for 2nd half of the F.Y. 2017-18 (October, 2107 to March, 2018)is being released.

It is therefore requested that special attention may be given to ensure smooth implementation of the Scheme immediately.
