Sub: Allotment of BPL rice and additional allocation of BPL Rice for issue under TPDS for the month of March, 2015.

Sir,

I am directed to communicate district wise allocation of **92163.175** MT of BPL Rice and additional allocation of BPL Rice for the month of March, 2015 for distribution under TPDS to the BPL consumers as per Annexure-I.

- Monthly allotment of 13192.950 MT BPL rice for the month of March, 2015 is hereby made for distribution under TPDS to the APL consumers in both Rural and Urban areas of KBK districts as per Annexure-II. Out of 2572.575 MT of BPL rice allotted to Kalahandi district 6.75 MT shall be lifted by C.S.O., Rayagada for distribution to the APL families of Gopinathpur, Kerpai, Odri and Maligaon G.P. under Th. Rampur Block of Kalahandi district.
- Out of 3656.900 MT of BPL rice allotted to Kalahandi district, 5.150 MT shall be lifted by the C.S.O.-cum-D.M., O.S.C.S.C. Ltd., Kandhamal for distribution to the BPL families of Lubengarh village of Urladani G.Ps of M. Rampur Block as they are inaccessible from Kalahandi district.
- Out of allotment of 3656.900 MT BPL rice in favour of Kalahandi district 57.9 MT of rice will be diverted to Rayagada district for distribution to BPL families of Gopinathpur, Kerpai, Odri and Maligaon G.P. under Th. Rampur block of Kalahandi district. The said stock of rice under BPL will be lifted by the C.S.O.-cum-D.M., Rayagada.
- 4. Out of allotment of 3656.900 MT BPL rice in favour of Kalahandi district 13.300 MT of rice will be diverted to Nawarangpur district for distribution to BPL families of Talnagi G.P. under Th. Rampur block of Kalahandi district. The said stock of rice under BPL will be lifted by the C.S.O.cum-D.M., Nawarangpur.
- Out of the allotment of 1425.825 MT of BPL rice in favour of Gajapati district, 11.425 MT will be lifted by C.S.O.-cum-D.M., O.S.C.S.C. Ltd., Rayagada for distribution to the BPL beneficiaries of 12 villages of Gordama G.P. under Mohana block of Gajapati district.
- 6. Other general instructions regarding scale of entitlement, sub-allocations and enforcement measures etc. communicated vide letter No.13657(30) / Food, Supplies and Consumer Welfare Department dated 20.6.2005 shall remain unchanged except consumer price.
- Each BPL card holder and APL card holders of KBK are entitled to lift 25 kg. of rice @ Re.1/-per Kg.
- 8. You are requested to deposit the cost of the said rice by 20<sup>th</sup> of February,2015 and ensure lifting of the allotted quantity by 28<sup>th</sup> February, 2015 positively.
- 9. Copies of sub allocation may be supplied to concerned Hon'ble M.Ps / M.L.As and Chairperson of P.S. for their information.
