- 3. The highest tenderer whose tender is accepted shall deposit immediately 25% of the offered amount as initial deposit. In case he fails to make deposit of the total amount as per the tender within the stipulated time, the deposit including the earnest money shall be forfeited. GST as admissible shall be levied on the bidding cost.
