I am directed to communicate district wise allocation of **92157.800** MT of BPL Rice (Both CP and SP) for the month of April, 2015 for distribution under TPDS to the BPL consumers as per Annexure-I.

- Monthly allotment of 13192.800 MT BPL rice for the month of April, 2015 is hereby made for distribution under TPDS to the APL consumers in both Rural and Urban areas of KBK districts as per Annexure-II. Out of 2572.575 MT of BPL rice allotted to Kalahandi district 6.75 MT shall be lifted by C.S.O., Rayagada for distribution to the APL families of Gopinathpur, Kerpai, Odri and Maligaon G.P. under Th. Rampur Block of Kalahandi district.
- 2. Out of 3656.375 MT of BPL rice allotted to Kalahandi district, 5.150 MT shall be lifted by the C.S.O.-cum-D.M., O.S.C.S.C. Ltd., Kandhamal for distribution to the BPL families of Lubengarh village of Urladani G.Ps of M. Rampur Block as they are inaccessible from Kalahandi district.
