Applications are invited from interested retired OAS Officers of the rank of Additional Secretary not above the age of 65 years having good service records and physical fitness for appointment as "Officer on Special Duty(01 post)" on contractual basis in Food Supplies and Consumer Welfare Department in pursuance of GA & PG Department Resolution No.23750, dt.27.08.2014.

2. The contractual engagement will be made for a period of six months subject to satisfactory performance by the contractual employee and his / her engagement shall not be extended beyond the age of 65 years. The competent authority reserves the right to terminate the engagement at any time by giving 15 days notice in writing.

3. The retired Officer against whom a vigilance case or Departmental Proceeding or Criminal prosecution is contemplated or pending or who has been penalized for misconduct during the preceding ten years of his/ her retirement or is a member of a political party will not be considered for reengagement.

4. Consolidated remuneration of the contractual employee shall be at the rate of Rs.42,000/- (Rupees Forty two thousand) only per month as per Finance Department Office Memorandum No. 7022/F., dated 17.03.2018.


5. The period of contractual engagement shall not be counted as Govt. service for the purpose of pension and any other retirement benefit.

6. The engaged officer will be subject to and will abide by the Conduct Rules applicable to the Government Servants.

7. The appointee will furnish an undertaking at the time of joining on duty regarding the truth and correctness of the information furnished by him/ her.

The interested retired OAS officer fulfilling the above criteria may apply with his/ her bio-data and history of service through the official mail id of FS & CW Department i.e. fscwsc@nic.in by **26.05.2021(3.00PM)** alongwith an undertaking that he/ she is not a member of any political party and no vigilance case or departmental proceeding or criminal prosecution is contemplated or pending against him/ her or he/ she has not been penalized for misconduct during the preceding ten years of his/ her retirement.


