ADVERTISEMENT FOR THE POST OF MEMBERS OF
ODISHA STATE FOOD COMMISSION

Applications are invited for appointment to the posts of whole time Members (five) in the Odisha State Food Commission, set up by Government of Odisha under the provisions of the National Food Security Act, 2013 (NFSA). The Members of the State Food Commission are to perform such duties and exercise such powers as prescribed under the NFSA, 2013 and Odisha State Food Commission Rules, 2016 and made thereunder. The Head Office of the Commission is at Bhubaneswar.

2. Scale of pay:

Basic Pay- Rs. 1,82,200/-(Fixed) with usual DA & other allowances fixed by Government from time to time.

Provided that if the Member, at the time of her/ his appointment is, in receipt of a pension, other than a disability pension, in respect of any previous service under the Government of India or under any State Government, her/his salary in respect of the service as the Member shall be reduced by the amount of that pension including any portion of pension which was commuted and pension equivalent of other forms of retirement benefits excluding pension equivalent of retirement gratuity.

Provided further that where the Member if, at the time of her/ his appointment is, in receipt of retirement benefits in respect of any previous service rendered in a Corporation established by or under any Central Act or State Act or a Government Company owned or controlled by the Central Government or State Government, her/ his salary in respect of the service as the Member shall be reduced by the amount of pension equivalent to the retirement benefits.

3. Eligibility Criteria:

The Members shall be appointed from amongst persons-

(a) who are or have been member of the All India Services or any other civil services of the Union or State or holding a civil post under the Union or State having knowledge and experience in matters relating to food security, policy making and administration in the field of agriculture, civil supplies, nutrition, health or any allied field; or

(b) of eminence in public life with wide knowledge and experience in agriculture, law, human rights, social service, management, nutrition, health, food policy or public administration; or

(c) who have a proven record of work relating to the improvement of the food and nutrition rights of the poor.

Provided that there shall be at least two women, whether Chairperson, Member or Member-Secretary:

Provided further that there shall be one person belonging to the Scheduled Castes and one person belonging to the Scheduled Tribes, whether Chairperson, Member or Member-Secretary.

4. Age limit and tenure: The Member, State Food Commission shall hold office for a term not exceeding three years from the date on which he enters upon the office and shall be eligible for re-appointment for a period of one year, provided that no person shall hold office as Member after she/he has attained the age of sixty-five(65) years. The Member shall not simultaneously hold any other office.

5. The applicants are advised to go through the provisions of National Food Security Act, 2013 and Odisha State Food Commission Rules 2016 and satisfy themselves about their eligibility and other conditions for being appointed as Member.
