**Sub:-** Allotment of PLO rice under TPDS for 19 poorest districts – distribution for each month of August, 2014 & September, 2014.

Madam / Sir,

With reference to the subject cited above, I am directed to communicate district-wise allotment of 15588.200 MT of PLO rice out of 193333 MT of additional allocation of BPL rice of Government of India for each month of August, 2014 & September, 2014 meant for poorest districts which may be distributed @ 25 Kg per family @ Re.1/- per Kg. per month identified under the above scheme as per details in the Annexure enclosed.

The total number of 623528 poorest families in 19 districts may be covered under the scheme.

A quantity of 2.725 MT of rice per month is diverted to Rayagada district for distribution of the same among 109 PLO families / beneficiaries of Garadama GP of Mohana Block of Gajapati District for each month of August, 2014 & September, 2014 due to transportation difficulties in Gajapati District.

The allotted quantity of 15588.200 MT of rice may be lifted out of Government of India additional allocation of BPL rice from Central Pool of CMR by 20<sup>th</sup> August, 2014 for month of August, 2014 & by 31<sup>st</sup> August, 2014 for month of September, 2014. Distribution should be completed by 22<sup>nd</sup> September, 2014 positively.

You are requested to kindly furnish lifting position of additional allocation of BPL rice and its distribution every month by the 5<sup>th</sup> of the subsequent month positively in the prescribed proforma to this Department without fail.
