You are requested to deposit cost of APL wheat so much in advance latest by 20.11.2014 and ensure lifting by 30.11.2014 positively. However, lifting of food grains in instalments against allocation within the validity period will be allowed.

The C.S.O.-cum-D.M., O.S.C.S.C. Ltd. concerned may be suitably instructed to take immediate steps for lifting of allotted quantity of APL Wheat from F.C.I. Copies of sub-allocation of APL wheat may be made in favour of Blocks / NACs/ Municipalities along with scale of supply may also be made available to concerned MPs/ MLAs /Youth Association/ Mahila Samities/ Chairman Panchayat Samities and Municipalities under intimation to this Department. Sub-Collectors and B.D.Os may be instructed to communicate dealer wise allotment to G.Ps with information of the concerned dealers for information of General Public.
