**Sub: State pool allotment of BPL rice for SC & ST Hostel for the month of March, 2014.**

Sir,

I am directed to communicate district wise allotment of 5603.250 MT of BPL rice for S.T. & S.C. Hostels, for the month of March, 2014 as per the quantity mentioned against each in the annexure enclosed. The scale of entitlement will be limited to 15 kg. per inmate per month @ Re.1/- per kg. uniformly. The entire quantity of this allotment will be provided by the OSCSC Ltd. from the State pool.

The validity period for deposit of cost and lifting of foodgrain for the months of December, 2013 to March, 2014 will be as per instant instruction of the Govt.


2. All other terms and conditions will remain unaltered. This allocation may be distributed only amongst the S.T. & S.C. Hostels as per the list provided by the S.T. & S.C. Development Department on the basis of intake capacity and number of inmates approved by the S.T. & S.C. Development Department.

3. There will be no diversion of rice from other schemes henceforth.

4. Institutions should be given entitlement cards to enable them to draw rice. The officers of concerned Department will certify utilization of stock for bonafide purpose in the card every month.

5. In case, closing stock is available with the institutions, equal quantity will be reduced from the allocation for the next month.
