With reference to the subject cited above, I am directed to communicate an allotment of 254.575 MT of rice per month in respect of the districts concerned for the month of June, 2014 for distribution among the Fishermen affected by ban on fishing for Olive Ridley Conservation (RORC) as per annexure enclosed.

The allocated rice will be distributed among the fishermen @ 25 Kg per card @ Re. 1/- per Kg. per month.

You are requested to lift the rice for the scheme (RORC) from DCP stock. The rice will be issued from the Additional APL rice allocated to the State by Government of India. Necessary steps may be taken to lift the allotted quantity soon after receipt of this allotment order on pre-deposit of cost. It may be distributed on regular basis along with other PDS scheme on pre-fixed dates. The guidelines issued earlier from this Department for implementation of the scheme for supply of rice @ Re1/- per Kg to Fishermen affected by ban on fishing for "Olive Ridley Conservation" may be adhered to scrupulously while distributing rice to the intended beneficiaries.

The lifting and offtake position of such rice may be sent to this Department for onward transmission to Government of India.
