## NOTIFICATION

No. 10.60 /Bhubaneswar, dated the 20.5 · 16

In exercise of the powers conferred by sub-section(2) of section 30 of the Consumer Protection Act, 1986•(68 of 1986), the State Government do hereby make the following rules further to amend the Odisha Consumer Protection Rules, 1988, namely:-

1. (1) These rules may be called the Odisha Consumer Protection (Amendment) Rules, 2016.

(2) They shall come into force on the date of their publication in the Odisha Gazette.

- 2. In the Odisha Consumer Protection Rules, 1988 (hereinafter referred to as the said rules), in rule 3-, (i) in sub-rule (I), in clause (c), for the words "rupees fifteen thousand per month", the words "rupees twenty five thousand per month" shall be substituted; and (ii) in sub-rule (2), in clause (a), for the words "rupees twelve thousand per month" wherever they occur, the words "rupees twenty thousand per month" shall be substituted.
- 3. In the said rules, in rule-6, in sub-rule (I), in clause (b), for the words "rupees twenty thousand", wherever they occur, the words "rupees thirty thousand" shall be substituted.
