District wise allotment of Foodgrains (Rice & Wheat) against PHH and AAY families under NFSA-2013 for the month of January'2016.

Madam/Sir,

I am directed to communicate district wise allocation of <u>1,37,3468.09</u> quintals of rice and <u>2,43,645.46</u> quintals of wheat from Central Pool for distribution among the Priority Households (PHH) and Antodaya Anna Yojana (AAY) households under NFSA-2013 for the month of **January'2016** as per enclosed Annexure.

Online Allotment Orders are being generated District wise for both PHH & AAY beneficiaries as per details in the newly issued ration cards. The District Civil Supplies Officer is to generate the Fair Price Shop wise allotment order from the system for each Block and ULB and communicate it to the concerned BDOs/ Sub Collectors/ ADMs with copy to EO of ULBs for further action at their level.

As per the provision of NFSA'2013 and as per decision of Government of Odisha, the PHH are entitled to get 5 (Five) Kilograms of food grain (rice, wheat or combination of both) per person per month @ Re.1/- per Kg. The AAY beneficiaries will continue to get 35 Kgs. of rice per household per month @ Re.1/- per Kg. The food grains (rice or wheat or both) shall be distributed to the PHH & AAY households against new ration cards issued under NFSA-2013 at the above prescribed rates.

- I. The per card entitlement of food grains (rice, wheat or combination of both) @ 5 kg per person per month @Re 1/- per kg shall be distributed to the priority house hold (PHH) under NFSA 2013.
- II. Per Card entitlement of food grains will not be reduced below the prescribed allotment. Minimum 25% verification of sale will be conducted by the Inspector of Supplies/ACSO in charge of the Block/ULB every month.
- III. The distribution of food grains may be taken up on fixed distribution days decided earlier during which all the dealers will keep their shops open and keep sufficient stock for the Consumers.

- If any entitled/ eligible ration card holder fails to receive his /her quota of PD. IV. commodities on the fixed days of distribution, he/she may be allowed to receive the same till the end of the month.
- All the PDS distribution should be completed by end of the allotment month. V.
- Undistributed allotment of food grains will be considered as Opening Balance VI. while finalising the allotment for the next month.
- Certificate of GPLAC or WLAC will be obtained on proper distribution of food VII. grains every month and submitted to the BDO/Sub Collector/ADM with counter signature of Inspector of Supplies/ACSO as per Annexure-1 of DSS Guidelines.

The CSOs-cum-DMs may be suitably instructed to take immediate steps for deposit of cost of wheat latest by 11th January 2016 with FCI and ensure lifting of the allotted quantity of wheat from FCI by 15th January 2016 positively. They are to be instructed to arrange rice at the DSC-cum-RRC for distribution to FPS by 15th January 2016. The distribution at FPS shall start with effect from 16th January 2016 till the end of the month.

Copies of sub-allocation may be made available to concerned MPs / MLAs / Chairpersons of Blocks/ULBs for their kind information under intimation to this Department.

You are requested to ensure distribution of foodgrains to the genuine ration card holders.
