Sub:- Allotment of rice under Annapurna Scheme for the months from July, 2011 to March, 2012.

Sir,

I am directed to communicate the district wise break up of 648 MT of rice for each month of July, 2011 to March, 2012 as indicated in the statement for distribution to the beneficiaries under Annapurna Scheme. The validity period for depositing of cost and lifting of the food grains for the month of July, August & September, 2011 will be 45 days and 50 days respectively from the date of issue of Govt. of India letter which was issued vide letter No.44/2011-BP-II dt.17.8.11. The validity period for depositing of cost and lifting of food grains for the remaining months will be as per guidelines issued earlier.

The allotted rice may be lifted immediately from the FSD, F.C. I. as per the quantity mentioned below against their districts and ensue distribution to the beneficiaries @10 kg per card free of cost. The unutilized rice under Annapurna Scheme kept with them may be surrendered to Govt. for re-allotment of the same to the Districts.

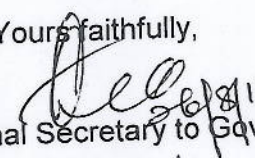

Out of allotment of 23.15 MT of rice under Annapurna Scheme for Kalahandi district 0.25 MT of rice is diverted to Rayagada District for distribution to the Annapurna beneficiaries of Kerpai, Gopinathpur, Odri and Malligaon G.P.s of Th. Rampur block. Similarly, out of 20.76 MT of rice under Annapurna Scheme for Jagatsinghpur district, 0.46 MT of rice is diverted to Cuttack district for distribution to the Annapurna beneficiaries of Uttarkula, Manijanga, Babujang and Mohanmadpur G.P.s of Nischintakoili block under Cuttack district.

Municipality /NAC / Block /G.P. wise distribution of the allotted stock of rice may be made under intimation to the concerned M.Ps / MLAs / Chairman Municipality/ PS.

The rice stock should be distributed to the beneficiaries at the place and time as communicated vide this Deptt. letter No.14261 dt.29.5.2002. Necessary steps may be taken to replenish the BPL rice, if utilized from the present allocation as intimated in this Deptt. letter No.14261,dt.29.5.2002
