Sub:- One time allotment of special adhoc/ additional wheat for APL families of the State.

Sir.

I am directed to communicate the break up of 23875 MT of Special adhoc/additional wheat for APL families as an one time allotment as per Annexure enclosed.

The validity period for lifting of Special adhoc/additional wheat has been extended upto 30.9.2011. You are requested to take steps for lifting of allocated quantity within validity period on pre-deposit of cost. The Central Issue Price of Special adhoc/additional wheat has been fixed at Rs. 8.45 per Kg.

The Consumer Price of Special adhoc/additional wheat is Rs. 9.15 per Kg. The quantity per consumer (APL card holder) comes to about Nine Kilograms.

Copies of sub-allocation of APL wheat may be made in favour of Blocks / NACs/ Municipalities along with scale of supply may also be made available to concerned MPs/ MLAs /Youth Association/ Mahila Samities/ Chairman Panchayat Samities and Municipalities under intimation to this Department. Sub-Collectors and B.D.Os may be instructed to communicate dealer wise allotment to G.Ps with information of the concerned dealers for information of General Public.

Collectors are further instructed to ensure that the allotted quantities are distributed to genuine card holders as per the guidelines mentioned below:-

- i. The awareness on additional provision of wheat @ Rs. 9.15 per Kg will be made by CSOs –cum-DMs at the district level and OSCSC Ltd. at the state level.
- ii. The Storage Agents and Retailers will maintain separate stock and sale account in respect of lifting and distribution of wheat @ Rs. 9.15 per Kg.
- iii.BDO / EO of the ULB will also give the Utilization Certificate on consumption of wheat @ Rs 7.00 per KG and @ Rs. 9.15 per Kg basing on the monthly return receipt of the Retailers. This is to be ensured by Marketing Inspectors by 7th of the month.
- iv.Retailers should maintain separate sale registers i.e., one for sale of normal wheat @ Rs. 7.00 per Kg another for sale of Special adhoc/additional wheat for APL families @ Rs. 9.15 per Kg.
- v. Strict vigilance may be kept over the matter so that allotted stocks of Special adhoc/ additional wheat are distributed as per TPDS procedure and no leakage/ diversion takes place.
- vi. Distribution of Special adhoc/ additional wheat to the genuine card holders may be ensured.
