**Sub:** FPS wise allocation of food grains (Rice & Wheat) against Priority Households and AAY Households under NFSA, 2013 for the month of **November, 2015.**

Madam/Sir

In continuation to the above referred letter, I am directed to inform that the FPS wise allocation of food grains for all the 14 districts (of 1<sup>st</sup> Phase) for the month of November, 2015 has been hosted in the Department's website [www.foododisha.in](http://www.foododisha.in). The allotment order for each FPS can be accessed through '**Beneficiaries List of NFSA 2013**' link provided in the homepage. It will open to '[OTPDS-Login page](#)' where you have to click "**Allotment under NFSA**" to open the search page. On the search page, you need to select your District and one Block/ULB after another to download **FPS wise allotment statement** for the concerned Block/ULB.

The Block/ULB wise allocation statement for the FPSs shall be generated by the District Office by following above procedure and sent to concerned Block/ULBs along with an allotment order. A sample letter is being

enclosed herewith (both hard copy & soft copy) which may be used by the District Office as allotment order for the Blocks/ULBs. The total quantity of allotment of Rice & Wheat reflected in the last two columns of the allotment statement for FPSs downloaded for the Block/ULB would be mentioned in the appropriate blank space in the allotment order. This manual arrangement for generating allotment order is being done for the allotment month of November'15. However, it is expected that by next allotment month, the allotment order would be integrated in the system so that it can be downloaded along with the allotment statement for the Block/ULB directly from the system.

Madam/ Sir,

With reference to the subject cited above and referred allotment orders for the month of November, 2015 issued by FS & CW Department, Government of Odisha, the FPS dealer-wise allocation for the month of November, 2015 is enclosed for necessary distribution. A total stock of \_\_\_\_\_ quintals of rice and \_\_\_\_\_ quintals of wheat from Central Pool for distribution among the Priority Households (PHH) and Antodaya Anna Yojana (AAY) households under NFSA-2013 for the month of November, 2015 may be lifted as per enclosed statement.

The following instructions may be followed strictly for ensuing meticulous distribution among eligible beneficiaries.

1. Timely financial arrangement by the FPS Dealers shall be ensured by the concerned Inspector of Supplies/ Marketing Inspector as per the Operational Guidelines of Departmental Storage System.
2. The door step delivery of allotted quantities of food grains by the concerned H&T Contractor (Level-II) to the respective FPS dealer shall be ensured sufficiently in advance by the concerned Procurement Inspector/ Inspector of Supplies/ Marketing Inspector before the dates of distribution.

3. Distribution of rice and wheat @ Re.1/- per kg shall be made in all the Fair Price Shops on 16<sup>th</sup> to 21<sup>st</sup> November, 2015 for the month of November, 2015. However, those beneficiaries who are not able to buy their stock with in above date may be allowed to buy their entitlements by 30<sup>th</sup> November, 2015.
4. Good quality of food-grains shall be distributed to each cardholder in the prescribed scale, on proper weighment and at the government fixed rate.
5. Any changes on retailer position / ration card tagging shall be intimated to the district administration prior to the month of allocation.
6. Complaints on non-distribution of food-grains, charging higher price, less weight & below quality norm shall be enquired into by the concerned Inspector of Supplies immediately and action shall be suggested to the proper quarters against the erring FPS licensees for punishment as per the provisions of O.P.D.S. (Control) Order' 2008.
7. A.C.S.O / Marketing Inspector / Inspector of Supplies of the concerned Block / ULB are to inspect numbers of F.P.S. as per the stipulation communicated earlier and also report feedback on contact with beneficiaries.

You are requested to send a copy of the Annexure to Hon'ble MLA, Hon'ble MP and PRI representatives namely [Sarpanches, Samiti members, Zilla Parisad member & Block chairperson] / [Ward Councillor, Corporator, ULB chairperson] and FPS dealers. An instruction to display the allotment order in GP notice board and at the Fair Price Shop for public awareness may be issued.
