Sub: Revised allocation of foodgrains to Odisha under existing TPDS and NFSA from November, 2015 onwards on account of implementation of National Food Security Act (NFSA) in 14 districts.

Sir,

I am directed to refer to your letter No. EC-R-14/2015(pt)-19823/FS&CW dated 06.10.2015 and letter No. 09-17-15-72/15-20331/FS&CW dated 14.10.2015 and this Department's allocation letter of even number dated 23.10.2015 on the above subject and to say that since Govt. of Odisha is implementing NFSA partially i.e. in 14 districts only from November, 2015, it has been decided to maintain total TPDS allocation (NFSA allocation + existing TPDS allocation for rest of the State) within the normal TPDS allocation given prior to implementation of NFSA. Accordingly, in partial modification of this Department's above mentioned letter dated 23.10.2015, the revised monthly allocation of foodgrains to Odisha from November, 2015 onwards will be as under:

2. Consequently, it has also been decided to make pro-rata reduction in the monthly additional APL and BPL allocation to the State. Accordingly, in partial modification of this Department's allocation letters No.1-2/2015-BP.III dated 19.10.2015, the monthly quantity of foodgrains under additional APL and BPL allocation from November, 2015 or till implementation of NFSA in the remaining non-NFSA districts of Odisha, whichever is earlier, will be as under:
