I am directed to communicate district wise allocation of 92204.725 MT of BPL Rice (Both CP & SP) for the month of January, 2014 for distribution under TPDS to the BPL consumers as per Annexure-I.

- Monthly allotment of 13242.900 MT BPL rice for the month of January, 2014 is hereby made for distribution under TPDS to the APL consumers in both Rural and Urban areas of KBK districts as per Annexure-II. Out of 2577.325 MT of BPL rice allotted to Kalahandi district 6.75 MT shall be lifted by C.S.O., Rayagada for distribution to the APL families of Gopinathpur, Kerpai, Odri and Maligaon G.P. under Th. Rampur Block of Kalahandi district.
- Out of 3661.750 MT of BPL rice allotted to Kalahandi district, 5.150 MT shall be lifted by the C.S.O.-cum-D.M., O.S.C.S.C. Ltd., Kandhamal for distribution to the BPL families of Lubengarh village of Urladani G.Ps of M. Rampur Block as they are inaccessible from Kalahandi district.
