I am directed to communicate district wise allotment of 8210.700 MT rice for boarders of S.T. & S.C. Hostels for the month of February, 2017 as per the quantity and number of boarders mentioned against each in the annexure enclosed. The scale of entitlement will be limited to 15 kg. per boarder per month @ Re.1/- per kg. uniformly. This allotment will be lifted from Central pool / State pool.

- 2. You are requested to deposit cost of rice so much in advance soon after receipt of the allotment order and ensure lifting and distribution by 31.01.2017 positively. All other terms and conditions will remain unaltered.
- **3.** This allocation may be distributed only amongst the S.T. & S.C. Hostels as per the list provided by the S.T. & S.C. Development Department on the basis of intake capacity and number of boarders approved by the S.T. & S.C. Development Department.
- **4.** There will be no diversion of rice from other schemes henceforth.
- 5. Institutions should be given entitlement cards to enable them to draw rice. The officers of concerned Department will certify utilization of stock for bonafide purpose in the card every month.
- **6**. In case, closing stock is available with the institutions, equal quantity will be reduced from the allocation for the next month.
