Sub:- Allotment of rice for the boarders of Kasturaba Gandhi Balika Vidyalayas (KGBVs) for the month of April, 2015.


Sir,

Copies of sub-allocation may be supplied to concerned Hon'ble M.Ps/ M.L.As and Chairperson of P.S. for their information.


