Allotment of BPL rice for S.T. & S.C. Hostels for the months of April to September, 2010 - from out of Central Government allotment.

Sir.

I am directed to communicate district wise allotment of 941.925 MT of BPL rice for S.T. & S.C. Hostels, for each month of April to September, 2010 as per the quantity mentioned against each in the annexure enclosed. The scale of entitlement will be limited to @ 12 kg. per inmate up to Class-VII and @ 15 kg. per inmate from Class-VIII to +3 @ Rs.2/- per kg. This allotment will be lifted from Central Pool stocks of F.C.I. / CMR of DCPS as per the lifting plan of the O.S.C.S.C. Ltd.

- This allocation may be distributed only amongst the S.T. & S.C. Hostels as per the 2. list provided by the S.T. & S.C. Development Department on the basis of intake capacity and number of inmates approved by the S.T. & S.C. Development Department. The rice will be lifted by the Storage Agents immediately and made physically available to the institutions. The validity period for deposit of cost and lifting of food grains for the month of April and May, 2010 will be up to 45 days and 50 days respectively from the date of issue of the letter of Government of India which was issued on 27.4.10. The validity period for the subsequent months of June to September, 2010 will be as per instant instruction of Government of India.
- 3. There will be no diversion of rice from other schemes henceforth with.
- Institutions should be given entitlement cards to enable them to draw rice. 4: The officers of concerned Department will certify utilization of stock for bonafide purpose in the card every month.
- The institutions will lift their quota from the concerned Storage Agent and they will 5. not be asked to lift rice from F.C.I. / D.P.C. Depots. S.A. will issue cash memo to the institutions and obtain signature. The rice utilize from the CMR may please be replenished.
- In case, closing stock is available with the institutions, equal quantity will be reduced from the allocation for the next month. However, full quota of Central Pool must be lifted by O.S.C.S.C. / S.A. and no quantity should be allowed to lapse.
