- 4. The C.S.O-cum-D.Ms, O.S.C.S.C. Ltd. may suitable be instructed to take immediate steps for timely lifting of the allotted stock of rice from Food Storage Depot, F.C.I. as per the quantity mentioned in the enclosed statement against their Districts.
