All Collectors.

Sub: Allotment of S.K.O. for the month of January, February & March, 2015. Sir/Madam,

I am directed to intimate that a quantity of 32376 K.L. Kerosene Oil for each month of January, February & March, 2015 is hereby distributed among all the districts as per following break up in multiples of 12 kl. so as not to allow lapses of allotted quantity to any district. The entire quantity of monthly allotment is to be lifted during the month of January, February & March, 2015 positively.

You are requested to lift the stocks of SKO from the respective oil companies. The wholesalers of your district should lift the entire stocks by 25th of the month. The C.S.O. should monitor the lifting of SKO by 10th, 20th and 25th of the month and report to Government about progress of lifting of SKO Problem if any such as non-availability of SKO with the company or bottleneck in transport etc. may be brought to the notice of Government.

The District level S.K. Oil distribution plan should be prepared taking into consideration of the fake/bogus/ghost cards detected.

Due care should be taken that PDS Kerosene is not diverted otherwise or misused for adulteration in MS / HSD retail outlets or commercial vehicles. Stringent action be taken against dealers found indulged in such unfair trade practices. Wide publicity be made on distribution, scale and quantum of supply.

The copy of the Block and Town-wise distribution of SKO may please be communicated to the Chairman of Vigilance Committees to check misuse of Kerosene under intimation to this Department. The utilization of SKO is meant for cooking and lighting purpose only.
