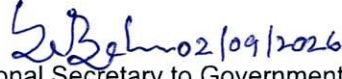
CORRIGENDUM

ADVERTISEMENT FOR THE POST OF MEMBERS OF THE
ODISHA STATE FOOD COMMISSION

Government have been pleased to order for publication of Advertisement inviting Applications for appointment to the 05 (five) posts of Member in the Odisha State Food Commission as per provisions in the National Food Security Act, 2013 and the corresponding Odisha State Food Commission Rules, 2016. The Member of the State Food Commission is to perform such duties and exercise such powers as prescribed under the aforesaid Act and Rules.

Scale of pay:

The salaries and allowances payable to the Member and other conditions of service shall be the same as that of the Principal Secretary to the Government.

Provided that if the Member, at the time of his/her appointment is, in receipt of pension, other than a disability pension, in respect of any previous service under the Government of India or under any State Government, his/her salary in respect of the service as the Member shall be reduced by the amount of that pension including any portion of pension which was commuted and pension equivalent of other forms of retirement benefits excluding pension equivalent of retirement gratuity.

Provided further that where the Member if, at the time of his/her appointment is in receipt of retirement benefits in respect of any previous service rendered in a Corporation established by or under any Central Act or State Act or a Government Company owned or controlled by the Central Government or State Government, his/her salary in respect of the service as the Member shall be reduced by the amount of pension equivalent to the retirement benefits.

Eligibility Criteria:

The Member shall be appointed from amongst persons:-

- (a) who is or has been member of the All-India Services or any other civil services of the Union or State or holding a civil post under the Union or State having knowledge and experience in matters relating to food security, policy making and



administration in the field of agriculture, civil supplies, nutrition, health or any allied field; or

(b) of eminence in public life with wide knowledge and experience in agriculture, law, human rights, social service, management, nutrition, health, food policy or public administration; or

(c) who has a proven record of work relating to the improvement of the food and nutrition rights of the poor.

Age limit and tenure: As per the Odisha State Food Commission Rules 2016, the Member shall hold office for a term of three years from the date on which he/she enters upon the office unless removed earlier and shall be eligible for re-appointment for a period not exceeding one year, provided that **no person shall hold office after he/she has attained the age of sixty-five (65) years.**

The applicants are advised to go through the provisions of National Food Security Act, 2013 and the Odisha State Food Commission Rules, 2016 and satisfy themselves about their eligibility and other conditions for getting selected for the post of Member.

The candidates who fulfil the eligibility criteria given above may send their applications in the prescribed proforma as hoisted in www.foododisha.in, under 'Important Information' link together with the self-attested copies of supporting documents addressed to "**The Additional Secretary to Government (NFSA), Food Supplies and Consumer Welfare Department, Loka seva Bhawan, Sachivalaya Marg, Bhubaneswar-751001**" through Speed Post on or before **17.09.2026** with specification on the top of the cover "**FOR THE POST OF MEMBERS OF THE ODISHA STATE FOOD COMMISSION**". The candidates working in Government/ PSUs/ Autonomous Bodies etc. must send their application through proper channel along with self-attested copies of the supporting documents.
