With reference to the subject cited above, I am directed to communicate allotment of 254.575 MT of rice per month out of 124908 MT of additional allocation of APL rice of Government of India in respect of the districts concerned for each month of November, 2014 to May, 2015 for distribution among the Fishermen affected by ban on fishing for Olive Ridley Conservation (RORC) as per annexure enclosed.

The allocated rice will be distributed among the fishermen @ 25 Kg per card @ Re. 1/- per Kg. per month.

You are requested to deposit the cost of the said rice so much in advance latest by 20th of preceding month for each allocation month. The lifting of rice should be completed by last day of the month preceding each allocation month.
