With reference to the subject cited above, I am directed to communicate district-wise allotment of 15588.200 MT of PLO rice out of 193333 MT of additional allocation of BPL rice of Government of India for the month of October, 2014 meant for poorest districts which may be distributed @ 25 Kg per family @ Re.1/- per Kg. per month identified under the above scheme as per details in the Annexure enclosed.

The total number of 623528 poorest families in 19 districts may be covered under the scheme.

A quantity of 2.725 MT of rice per month is diverted to Rayagada district for distribution of the same among 109 PLO families / beneficiaries of Garadama GP of Mohana Block of Gajapati District for the month of October, 2014 due to transportation difficulties in Gajapati District.
