Madam / Sir,

With reference to the subject cited above, I am directed to communicate district-wise allotment of 15588.200 MT of PLO rice out of 193333 MT of additional allocation of BPL rice of Government of India for each month of November, 2014 to March, 2015 meant for poorest districts which may be distributed @ 25 Kg per family / beneficiaries @ Re.1/- per Kg. per month identified under the above scheme as per details in the Annexure enclosed.

The total number of 623528 poorest families in 19 districts may be covered under the scheme.

A quantity of 2.725 MT of rice per month is diverted to Rayagada district for distribution of the same among 109 PLO families / beneficiaries of Garadama GP of Mohana Block of Gajapati District for each month of November, 2014 to March, 2015 due to transportation difficulties in Gajapati District.

You are requested to deposit the cost of the said rice so much in advance latest by 20th of preceding month for each allocation month. The lifting of rice should be completed by last day of the month preceding the each allocation month.

Hence the total allotted quantity of 77941.00 MT of rice for the period of 5 months i.e., from November, 2014 to March, 2015 should be lifted as per the above stipulation & distributed to the genuine beneficiaries / families within the stipulated period.

You are requested to kindly furnish lifting position of above rice and its distribution every month by the 5th of the subsequent month positively in the prescribed proforma to this Department without fail.
