**Sub: Allotment of Additional APL Wheat for the month of April & May, 2015.**

Sir,

In continuation to this department Letter No. 5407, dated 13.03.2015 & Letter No. 7067, dated 06.04.2015. I am directed to communicate district-wise allotment of **10697.307** MT of Additional APL wheat for the month of April, 2015 & **10697.202** MT of Additional APL Wheat for the Month of May, 2015 respectively as per the quantity mentioned against each district and principles as per Annexure-I & II. The allocation may be considered under the Additional APL wheat category of the T.P.D.S. The Collector, Cuttack is requested to ensure distribution of Additional APL wheat to all the APL beneficiaries of 4 G.Ps namely Utarkula, Manijang, Babujang and Mahammadpur under Nischintakoili Block of Cuttack district.

You are requested to deposit of cost and lifting of the above additional allotment for the month of April, 2015 upto 30.04.2015 and for the Month of May, 2015 upto 10.05.2015 respectively.

However, lifting of food grains in installments against allocation within the validity period will be allowed. The lifting and offtake position of Additional APL wheat may be furnished to this department immediately.

The C.S.O.-cum-D.M. O.S.C.S.C. Ltd. may be suitably instructed to take immediate steps for lifting of allotted quantity of Additional APL Wheat from F.C.I. Copies of sub-allocation of Additional APL wheat may be made in favour of Blocks / NACs/ Municipalities along with scale of supply may also be made available to concerned MPs/ MLAs / Youth Association/ Mahila Samities/ Chairman Panchayat Samities and Municipalities under intimation to this Department. Sub-Collectors and B.D.Os may be instructed to communicate dealer wise allotment to G.Ps with information of the concerned dealers for information of General Public.

Collectors are requested to ensure distribution of Additional APL wheat to the genuine card holders as per the Annexure I & II. Further they are also requested to ensure that the genuine APL card holders of all the districts except Gajapati & Nabarangpur are being provided with 10kg of Wheat (7kg Normal+3kg Additional) for each month of April, 2015 & May, 2015. The Collectors of Gajapati & Nabarangpur districts are requested to ensure that the genuine APL card holders of their districts are being provided with 5kg and 6kg of Wheat respectively for each month of April & May, 2015.
