I am directed to communicate district wise allocation of 92129.250 MT of BPL Rice (From CP, additional CP and SP) for the month of July, 2015 for distribution under TPDS to the BPL consumers as per Annexure-I.

- 1. Monthly allotment of 13176.850 MT BPL rice for the month of July, 2015 is hereby made for distribution under TPDS to the APL consumers in both Rural and Urban areas of KBK districts as per Annexure-II. Out of 2568.850 MT of BPL rice allotted to Kalahandi district 6.75 MT shall be lifted by C.S.O., Rayagada for distribution to the APL families of Gopinathpur, Kerpai, Odri and Maligaon G.P. under Th. Rampur Block of Kalahandi district.
- 2. Out of 3647.050 MT of BPL rice allotted to Kalahandi district, 5.150 MT shall be lifted by the C.S.O.-cum-D.M., O.S.C.S.C. Ltd., Kandhamal for distribution to the BPL families of Lubengarh village of Urladani G.Ps of M. Rampur Block as they are inaccessible from Kalahandi district.

- 8. You are requested to deposit the cost of the said rice by 20th of June, 2015 and ensure lifting of the allotted quantity by 30th June, 2015 positively.
