**Sub: Allotment of BPL rice for SC & ST Hostel from central pool for the month of July, 2015.**

Sir,

I am directed to communicate district wise allotment of 941.925 MT of BPL rice out of Government of India allocation for S.T. & S.C. Hostels, for the month of July, 2015 as per the quantity mentioned against each in the annexure enclosed. The scale of entitlement will be limited to 15 kg. per inmate per month @ Re.1/- per kg. uniformly. This allotment will be lifted from central pool on pre deposit of cost. The validity period for depositing the cost latest by 20.06.2015 and lifting of above rice by 30.06.2015 positively.

2. You are requested to deposit cost of rice soon after receipt of this allotment order and ensure lifting & distribution of rice by 30.06.2015 positively. All other terms and conditions will remain unaltered.

3. This allocation may be distributed only amongst the S.T. & S.C. Hostels as per the list provided by the S.T. & S.C. Development Department on the basis of intake capacity and number of inmates approved by the S.T. & S.C. Development Department.

4. There will be no diversion of rice from other schemes henceforth.

5. Institutions should be given entitlement cards to enable them to draw rice. The officers of concerned Department will certify utilization of stock for bonafide purpose in the card every month.

6. In case, closing stock is available with the institutions, equal quantity will be reduced from the allocation for the next month.
